All schools are hereby directed to undertake the Updation of Section 12(1)(c) Student Data for Reimbursement and Retention Verification, including entry and validation of details of all previously admitted students, both online and offline, along with attendance records, academic progress reports, and prescribed documentation. Schools shall also generate and submit invoices for reimbursement against all eligible children admitted under Section 12(1)(c) of the RTE Act, 2009, within the stipulated period.

All District Education Officers are requested to take appropriate steps and issue necessary instructions to all Recognised Private Managed Schools accordingly for the implementation of the online system of admission under Section 12(1)(c) of the RTE Act, 2009.
